COBRA

RETIREMENT SAVINGS PLAN (401K)

BASIC AND SUPPLEMENTAL EMPLOYEE AND DEPENDENT LIFE AND AD&D (Lincoln)

- Upon your termination of employment (prior to the age of 65) Portability is available on Optional Employee Life and Optional Dependent Life (up to \$500,000). Basic Employee Life, Optional Employee Life, and Optional Dependent Life have the option of Conversion upon termination of employment.
- **Portability:** Portable means you continue your existing term life insurance to age 65 without having to satisfy evidence of good health. Rates are based on age at each renewal period. Portability is usually less expensive than converting to a permanent plan but premiums increase with age. There is a limited time to "Port" - Lincoln must receive *Portability Application* & first premium within 31 days of date of termination. **Refer to the Portability Form for more details. This can be found on our benefits website at www.akusbenefits.com on the Employee Off-Boarding tab.**
- **Conversion:** Conversion means you obtain permanent life coverage without evidence of insurability. Rates for this coverage are generally more expensive than for Portability, however, premiums remain level. There is only a limited time to convert. Lincoln must receive *Conversion Application* & first premium within 31 days of your date of termination. **Refer to the Conversion Form for more details.
